**1. Permission to apply topical ointments (bug spray, sun block, antibiotic ointment)**

**4. Child Abuse and Neglect**

My child \_\_\_\_\_ has permission to ride the horse at Canterbury Creek Farm Preschool. I understand that my child will participate in horse riding/animal feeding, and related activities. I further understand that riding horses, feeding animals, and related activities are inherently dangerous. Even when all reasonable precautions are taken, riders/participants may be injured. I understand that the dangers and risks associated with riding horses, animal feeding, and related activities include, but are not limited to, death, serious neck and spinal injuries which may result in complete or partial paralysis, brain damage, serious injury to internal organs, serious injury to bones, joints, ligaments, muscles, tendons, and other parts of the body and transmission of infectious disease. I further understand that I am fully responsible for the costs of treatment of any injury suffered by my child while riding horses or participating in related activities.

In consideration of my child being allowed to participate in horse-riding, animal feeding and related activities, I agree to indemnify, defend and hold harmless Canterbury Creek Preschool and Canterbury Creeks respective employees, directors, officers, or any member of its workforce, against all actual and direct losses suffered by Canterbury Creek and all liability arising from or in connection with my child participating in the aforementioned activity including any claim brought or prosecuted by the child for negligence or wrongful acts or omissions, by the preschool or its employees directors, officers or any member of its workforce. Accordingly, on demand, I will reimburse the preschool for any and all actual and direct losses, liabilities, lost proceeds, fines, penalties, costs or expenses (including reasonable attorneys' fees) which may for any reason be imposed upon Canterbury Creek Preschool or members of its workforce by reason of any suit, claim, action, proceeding or demand by the child. My obligation to indemnify Canterbury Creek Preschool shall survive the expiration or termination of this consent.

I further acknowledge that I have been informed and understand that the Michigan Equine Activity Liability Act (MCLA 691-1661) provides that an equine sponsor is not liable for an injury to or the death of a participant or property damage resulting from an inherent risk of an equine activity.
